IN RETURN FOR THE USE OF THE PROPERTY, FACILITIES, HORSES AND SERVICES OF THE TOPPING RIDING CLUB (TRC) BY THE UNDERSIGNED AND/OR ANY CHILDREN NAMED BELOW, THE UNDERSIGNED HEREBY EXPRESSLY AGREES FOR HIM OR HERSELF AND ON BEHALF OF HIS OR HER HEIRS, ASSIGNS AND LEGAL REPRESENTATIVES TO THE FOLLOWING:

- a. THE UNDERSIGNED EXPRESSLY ASSUMES RESPONSIBILITY FOR ALL RISKS INVOLVED IN OR ARISING FROM HORSEBACK RIDING BY THE UNDERSIGNED AND ANY CHILDREN NAMED BELOW (COLLECTIVELY, THE "RIDER"), including but not limited to risks arising from the propensity of horses to behave in a dangerous way and the inability to predict a horse's reaction to sound, movements, objects, vehicles, persons or animals, and hazards of surface or subsurface conditions whether natural or man made, which may result in injury or death to the Rider.
- b. The undersigned understands and agrees that horses and equipment provided, leased or sold by TRC to the Rider are provided, leased or sold with out warranty that they are fit to use for any purpose or for a specific purpose, that such horses and equipment are leased or sold on an as is basis and that no warranty or representation is made as to the adequacy of training provided by TRC personnel.
- c. The undersigned does and shall waive all rights against, and does and shall forever discharge and release from liability, TRC, its directors, officers, employees and agents, and the owners, lessees, lessors or licensees of all premises on which the Rider is present at any time in connection with his or her activities at or with TRC and any successors assigns, heirs or personal representatives of any of the foregoing (collectively the Released Parties) for all claims which the undersigned or the Rider may now or hereafter have for any injury directly or indirectly related to horseback riding with TRC or any use of or presence upon TRC property or facilities or any other activity conducted by TRC or its designers, including but not limited to physical injury or death economic or pecuniary loss cost or expense mental or emotional injury, or property damage.
- d. To the extent permitted by applicable laws, in connection with his her activities at with or conducted by TRC (or any of its designees or his or her use of, or presence upon TRC property or facilities the undersigned is and shall be responsible and liable for all injuries including but not limited to physical injury or death, economic or pecuniary loss cost or expense mental or emotional injury or property damage in each case arising from related to based upon or attributable to the acts omissions of the undersigned or the Rider.
- e. The undersigned does and shall indemnify the Released Parties from any claim, loss cost or expense arising from, related to based upon or attributable to the acts or omissions of the undersigned or the Rider.

The Release shall be governed by the Laws of the State of New York. The undersigned agrees that any dispute concerning this document or arising from the activities of the undersigned or the Rider may only be pursued in the court of the State of New York and the venue for any such dispute shall be solely in the County of Suffolk.
